As members of the Task Force and fellow entrepreneurs, we want to hear from you – what could government do to better support business success in your community? We will be visiting your region in June and invite you to join us on **Tuesday**, **June 26**th, **2018 in Cranbrook from 10:00 am to 12:30 pm** to share your ideas in person. At the engagement session, you will have the opportunity to participate in small group discussions where you can provide your suggested solutions to each of the discussion topics below. In your RSVP, as noted below, please indicate which three of the topics are of highest priority to you. The topics include:

- 1. Managing the Cost of Doing Business in B.C. (e.g. operating costs, wages and employee housing)
- 2. Supporting the Diverse Needs of Small Businesses and Entrepreneurs to Start Up and Grow (e.g. rural and remote, women, newcomers to B.C., persons with disabilities and youth)
- 3. Addressing Employment and Skills Training Needs.
- 4. Increasing Awareness of and Access to Government Programs and Services.
- 5. Improving Government Interactions with Small Business.

To ensure business owners in every area of B.C. have an opportunity to provide their input, we have also set up a concurrent online survey that will be open throughout the month of June. The website will launch June 1st at: engage.gov.bc.ca/smallbusiness.

In addition to the community engagements and survey, the Task Force will seek online comments on a Discussion Paper in July. Based on all of the above, we intend to submit our report to the Minister in October, 2018.
